Community Development Director Kempenaar stated at the last City Council Strategic Planning meeting in May 2022, the City Council directed staff to present the Council with options for potential annexation areas. He stated the areas being considered are Roseville Pointe, Fair Oaks/Madison, Dewey Drive (area on the southern side of the City), and the Greenback Gateway. The potential work plan includes a strategic review of the annexation areas, initiating dialogue with Sacramento County, conducting targeted outreach to impacted geographies, conduct a preliminary fiscal impact analysis, and report the findings to the City Council.

12. **SUBJECT:** Patriotic Event Considerations – Professional Fireworks

**RECOMMENDATION:** Adopt Resolution No. 2023-013, A Resolution of the City Council of the City of Citrus Heights, California, Approving a Not to Exceed Allocation of \$80,000 of American Rescue Plan Act Funds for a Patriotic Community Event in Recognition of Independence Day and Finding the Event Categorically Exempt from the California Environmental Quality Act

City Manager Feeney stated in working with the City Council and the community we developed a Focus Area Work Plan that was put forward to allow us to advance in certain areas that are of interest to the community. One of the four focus areas that emerged over the last year is Community Connection. In the City's current sixmonth strategic objectives the Council established an objective to "explore the feasibility, costs, logistics and options for a patriotic event and present to City Council." Some patriotic event considerations include time and planning, location, music, food and beverage, and professional fireworks. He provided an overview of the potential 2023 event scope. The event would likely be held on Friday, June 30 or Saturday, July 1, at the City Hall campus and Van Maren Park, it would include a musical performance, some food and beverage, and a professional fireworks show. The estimated costs for the event are between \$60,000 to \$80,000. Staff is recommending the use of American Rescue Plan Act funding to fund the event. If the Council desires this to be an annual event, the costs would be budgeted in the next two-year budget cycle. He stated several emailed public comments have been received and were provided to the City Council.

#### **Public Comment**

Lee Miller, with Residents Against Illegal Fireworks in Sacramento County, spoke via Zoom and encouraged Council to vote no on just the professional fireworks portion of the resolution. In her opinion she said it would be better to use the funds that are being allocated for the aerial fireworks to enforce Citrus Heights' illegal fireworks social host ordinance.

Kristie Wardlow spoke via Zoom and asked when the parade would come back. She believes the 4<sup>th</sup> of July community parade is something important that should come back to Citrus Heights.

City Clerk Van read the following public comment submitted by Alfred Sanchez, "No way should we spend any money on a fireworks show. We need to focus our money on better things. I am strongly apposed. Don't do it!"

City Clerk Van read the following public comments submitted by Kathy Milton, "I am completely against any funds used for this proposal. I concur with Linda Sue Arrowwood in her letter to the Sentinel editor. (Excerpts from her article) There are numerous ways to help people and businesses that should be considered before any entertainment funding that is not beneficial to the entire community. Perhaps... Grants for local businesses, Assistance for our local homeless population; consider port-o-potty areas, trash service etc. Help out senior citizens with limited incomes buy food or pay a utility bill. Fund a grant to assist our local marching band with expenses or a local nonprofit to benefit children. At the very least, fix some potholes or help those who need to remove storm-damaged trees and debris. Help fund something to assist Police Department personnel, like body armor or mental health assistance for police officers and their families... \$80k is a frivolous expense. Poll the citizens and use the funds as intended."

#### Council comments followed.

Vice Mayor Daniels made a motion to adopt Resolution No. 2023-013, A Resolution of the City Council of the City of Citrus Heights, California, Approving a Not to Exceed Allocation of \$80,000 of American Rescue Plan Act Funds for a Patriotic Community Event in Recognition of Independence Day and Finding the Event Categorically Exempt from the California Environmental Quality Act. Council Member Middleton seconded the motion.

Mayor Schaefer made an alternate motion to adopt Resolution No. 2023-013, A Resolution of the City Council of the City of Citrus Heights, California, Approving a Not to Exceed Allocation of \$80,000 of American Rescue Plan Act Funds for a Patriotic Community Event in Recognition of Independence Day and Finding the Event Categorically Exempt from the California Environmental Quality Act, with the removal of the professional fireworks component of the event.
